

Household Hazardous Waste

Household hazardous waste products are waste materials that can be harmful to human health or the environment if used, stored or thrown away improperly. These wastes are the leftovers from common household products we all have in our homes. When the product is no longer useable or wanted, it becomes household hazardous waste. Between 3 – 10 gallons of household hazardous waste can be found stored in an average household.

How do you know what products are hazardous?

- Read the product label. Signal words provide a quick and easy way to judge a product's hazard level:
 - **CAUTION:** Mild / Slightly Hazardous
 - **WARNING:** Moderately Hazardous
 - **DANGER:** Extremely Flammable, Corrosive or Toxic
 - **POISON:** Highly Toxic
- Many product labels give instructions on how to use the product and how to properly dispose of product leftovers. Examples of household hazardous waste products include: paint, fertilizer with weed killer, household cleaning products, etc.

<i>HOT TIP!</i>	Buying carefully, storing carefully, and using carefully will prevent household hazardous waste and protect the environment. It is always important to buy the least hazardous product to get the job done.

What should I do with my household hazardous waste?

- Don't throw it in the trash.
- Don't pour it in the sewer.
- Don't pour it on the ground.
- Take it to a Household Hazardous Waste Collection.

YOU ARE IN CONTROL!! Prevent hazardous disposal problems by reading the product's label and buying products that are less toxic to get the job done.

These collections are only to households, **NO BUSINESS WASTE** is accepted. If you have business waste, you may need to use the small quantity generator program in Martin and Faribault Counties.
